Minutes of the Meeting on Flood Damage Assessment held on 26.07.2017 at 10.30 AM at the Conference Hall, O/O the Deputy Commissioner, Nagaon

A meeting on flood damage assessment was held on 26/07/2017 at the Conference Hall, O/o the Deputy Commissioner, Nagaon. Sri Shamsher Singh, IAS, Deputy Commissioner & Chairman, DDMA, Nagaon chaired the meeting. He initiated the discussion and welcomed all the participants present. At the outset the Deputy Commissioner apprised the house about the visit of Central Team in the State.

After a thorough discussion the following decisions were taken:-

- 1. The Deputy Commissioner & Chairman, DDMA, Nagaon requested all the HOD's of the department to report of damage of any infrastructure immediately to DDMA, Nagaon i.e. within 24hrs of the incident in the daily flood situation report through concerned Circle Officer.
- 2. All the HOD's of the department to instruct their departmental Nodal Officer for Disaster Management for taking active role and to coordinate with Circle Officers and DDMA for sharing of any disaster related information.
- 3. Addl. Deputy Commissioner & CEO, DDMA, Nagaon apprised the house about the special assistance to the mostly flood affected families of the district by Indian Red Cross Society. In this connection a team of Indian Red Cross Society visited the flood affected areas of Kaliabor Sub-division.
- 4. The meeting also approved the 6 nos. Ex gratia proposal against the death occurred due to flood 2017. All the NOK's of the deceased paid Rs. 4, 00,000/- each immediately within 48 hrs. of the incident. The details are as follows:-

- 5. The Deputy Commissioner & Chairman, DDMA, Nagaon directed all the Circle Officers to complete all the damage assessment work and submit house damage report accordingly to DDMA, Nagaon in the prescribed format.
- 6. The Deputy Commissioner & Chairman, DDMA, Nagaon directed all the HOD's of the department to submit flood damaged report with related photographs of any infrastructure before 4 P.M. on 26th July, 2017 for compilation of report/ PPT etc. by DDMA.
- 7. The meeting decided for restoration as well as cleaning and white washing of the schools used as relief camps after leaving inmates. The rate of the restoration work should @ Rs. 1, 00,000/- maximum or as per actuals. In this connection an approval from the Govt. for utilizing the GR fund provided to the district will be required.
- 8. The meeting approved to procure one Scanner for DDMA, Nagaon from the interest fund GR kept in the DDMA, bank account.
- 9. The meeting approved the estimate against the work "Anti-Erosion measures to protect Bakulaguri and Bareguga from erosion of river Kopili" an amount of Rs. 7,95,99,000/- submitted by Executive Engineer, Water Resources, Nagaon Division. (NRR.107/2017)
- 10. The Deputy Commissioner directed all the Circle Officers to submit RG (House damage) proposal and HOD's of the department to submit SDRF proposal with Plan & Estimate against damaged infrastructure due to flood, 2017 for approval in the next DDMA meeting.
