**ORDER**

No. NSG (Case) 19/2012/34 :- Whereas, the retail licence under the "Assam Public Distribution of Articles Order'1982" of Sri Manash Sarma an FP Shop agent of M/S Hatichung GPSS was cancelled vide this office order No. NSG (Case) 19/2012/25, dtd. 27/08/2012, following a complaint case against him.

Whereas, Sri Manash Sarma, FP Shop agent of M/S Hatichung GPSS filed an appeal petition before the Commissioner, North Assam Division on the cancellation order of his licence where in the Commissioner, NAD remitted the appeal petition to this end for further enquiry and review of the matter.

Whereas, on receipt of the order vide No. CAN/RR. II/2012/80, dtd. 21/02/2013 from the Commissioner, North Assam Division, the petitioner was directed to appear before the undersigned vide this office letter No. NSG (Case) 19/2012/31, dtd. 06/06/2013 alongwith all the documents he intends to rely upon to present his case.

Whereas, Sri Manash Sarma, FP Shop agent under M/S Hatichung GPSS appeared before the undersigned on 10/06/2013. He was personally heard and his statement was also recorded. His statement was similar to his earlier deposition and he again fails to convince his innocence in diversion of highly subsidized PDS SK Oil.

Therefore, his licence No. NSG 349 (R)/2011 under the APDA Order'1982 be cancelled forthwith. The sale proceed of the seized 440 litres of SK Oil is confiscated to the State but the security deposit against his licence may be returned to him alongwith accrued interest there on.
