

Sub :- Regarding computerisation of Individual Family Identity Cards and data entry of PDS beneficiaries.

Ref :- This office message vide no. NSG.142/2011/16 dtd. 21/02/2012 and no. NSG.142/2011/18 dtd. 05/03/2012.

Sir,

With reference to the office communication noted above, I have the honour to inform you that the process of detection of spurious family identity cards started again in Nagaon as a prelude to the issue of fresh FI cards on the basis of data collection from field level. More than six thousand fake cards have been detected in this fresh exercise till date and these cards have been manually cancelled.

Data collection from field level need to be started as early as possible and a large amount of fund is required for printing of formats, collection of data from field level and actual data entry in software. The requirement of fund for the purpose was earlier submitted to the Director of Food, Civil Supplies and Consumer Affairs vide this office message no. under reference above. The total requirement of fund for Nagaon Sub-Division was worked out to be Rs. 26,26,900/- (Rupees twenty six lakh twenty six thousand nine hundred) only. However, actual works could not be started till now for want of required fund.

Further, the exercise for collection of house to house data of APL, BPL and AAY beneficiaries is a massive exercise and it is felt that unless employees of other departments are involved, it cannot be completed in time. However, in the light of the order of Hon'ble Supreme Court of India not to involve teachers etc in works other than election and census, there is much difficulty in accomplishing the task on time.

Therefore, I request you to kindly take necessary steps for early release of the required fund and pass suitable instruction regarding proposal for engagement of employees from other departments for the exercise in the interest of early completion.


