- (3) The right to be assured wherever possible, asses to a verity of goods at competitive prices.
- (4) The right to be heard and to be assured that consumer interest will receive due consideration at appropriate forum.
- (5) The right to redressal against unfair trade practice or unscrupulous exploitation of consumers.
- (6) The right to consumer education.

The Council will have a sitting once in a quarter. One third of the total number of members present will form a quorum.


